JUDGE JOHN E. HUBER RECONCILIATION AGREEMENT

- 1. Petitioner, Steven John Donahue, spouse of Linda Lefebvre Donahue–Ward/Protected Person, has Spousal Priority under Neb. Rev. Stat. § 30-2627, is an interested party in her welfare pursuant to Neb. Rev. Stat. § 30-2619 and § 30-2633, and in these proceedings.
- 2. Petitioner has reflected upon the comments of this Court; reviewed over 15-years of emails, journal entries, and other documents about the relationship among the Guardian, the Petitioner, and Linda: heartend by a 15-year history of partnership between the Guardian and himself to care for Linda; and proposes a Reconcilation Agreement below.
- 3. Petitioner proposes the following points of a Reconcilation Agreement among the parties:
- (a) Preserving the present Guardian Carol Lefebvre Toto;
- (b) Proposing Communication methods between the Guardian and Petitioner;
- (c) Performing a Medical evaluation within about six months;
- (d) Appointing of a Successor Guardian/Conservator;
- (e) Continuing of Family/Marriage Therapy for the spouses.

- 4. Petitioner agrees Carol Lefebvre Toto shall remain the Guardian. Taking care of Linda since her 2010 stroke has been a challenge met by the cooperation between myself and my sister-in-law. She is a good and loving sister to Linda and sister-in-law to me. We have a long and complex relationship. We have been partners, confidants, and friends. It is imperative, for Linda's sake, that this relationship continue in some fashion or another.
- 5. Petitioner agrees to send a weekly email to the Guardian which will professionally summarize Linda's progress, regression, activities, needs, and so on. Petitioner will respectively respond to any additional information the Guardian may request or for the Petitioner to do. Any phone calls made will be at the Guardian's discretion.
- 6. Petitioner agrees that Linda will get a full Medical Examination in about six months by Practitioner(s) mutually agreed to by the Guardian and Spouses. This aspect of the Reconcilation Agreement shall be non-confrontational and loving and in the best interests of Linda as its objective. This six-month period may hold the key to a needed Reconcilation among the parties.
- 7. Petitioner agrees that he shall be appointed the Successor Guardian/Conservator and has completed the Public Guardian's training curricula and met other requirements per Neb. Rev. Stat. § 30-2601.01 and has previously supplied these to the Court.
- 8. Petitioner agrees that Linda and he shall continue Family/Marriage therapy with Clifton Hobbs III, MS, LIMHP, NCC to work on individual or common issues. Attached hereto and incorporated herein, is a letter from U Re-Imagined Counseling Services, marked as Exhibit 1.[N.B. All counselling sessions took place before the recent February 12, 2025 hearing. All standing appointments have been cancelled.]

WHEREFORE, Petitioner requests that this Court fix a time and place for hearing of this petition;


That notice be given to all persons entitled thereto as provided by law;
