MOTION TO ORDER MEDIATION OR ALTERNATIVE DISPUTE RESOLUTION

COMES NOW, Steven John Donahue, Movant ar 4 Spouse of the Protected Person, Linda M. Lefebvre Donahue, by and through himself. Pro Se, asks the Court for an Order to appoint a Mediation or Alternative Dispute Revolution, such as an Initial Private Session, to resolve issues between the Guardian and himself in regards to providing care for Linda. See Neb. Rev. Stat. § 25-2901 to § 25-2903

- 1. Movant, Steven John Donahue, as spouse, of Linda Lefebvre Donahue–Ward/Protected Person, with Spousal Priority under Neb. Rev. Stat. § 30-2627, is an interested party in her welfare pursuant to Neb. Rev. Stat. § 30-2615 and § 30-2633 and in these proceedings.
- 2. Douglas County, Nebraska is the Movant's place of residence.
- 3. Linda Lefebvre Donahue, about whom Mediation or Alternative Dispute Resolution is sought, and who had a debilitating stroke on March 31, 2010, and numerous medical setbacks 2021-2022, has been a resident at the Prestige Care Center in Plattsmouth.

- 4. Venue for this proceeding is proper in Douglas County because the above named person, Linda Lefebvre Donahue resided in Douglas County as defined as Neb. Rev. Stat § 30-2618 at the time of the prior filings.
- 5. Communication between the Guardian and Steven Donahue has completely broken down.
- a. The current Guardian, Carol Lefebvre Toto, stated in her Motion to Resign that a Successor Guardian is necessary because of a break own in the relationship with the Protected Person and her Spouse.
- b. The current Guardian has stated during a recent three-way call between Kathleen Pallesen, esq., and Kelly Henry Turner, esq. that "It is never going to happen" referring to re-establishing fruitful communications between brother and sister-in-law.
- 6. This Movant has filed a Petition for a Reconcilation Agreement that includes Proposing Communication methods between the Guardian and Petitioner.
- 7. All entreaties for communication from the Mova it to the Guardian have been ignored and rebuffed for about the past six months.
- 8. Movant asks the Court to refer this civil case to Mediation or Alternative Dispute Resolution and/or an Initial Private Session, unless otherwise ordered following a hearing upon a motion to object to such referral, may state a date for the case to return to Court. Neb Rev. Stat. § 25-2943
- 9. There are a number of benefits to such a Mediati in or Alternative Dispute Resolu-

tion when there is disagreement among family members, including:

- a. Personalized solutions to difficult problems.
- b. Movant and Guardian will have direct input in the solutions agreed upon, instead of relying solely on a Judge's opinion.
- c. Mediation can resolve legal issues, and can also he'p with personal or familial problems.
- d. Preserves relationships by using a collaborative process instead of an adversarial process.
- e. Reduces the likelihood of future, reoccurring dist ates by helping the other participants find ways avoid or manage future disagreemen s.
- f. Can save time and money.
